- (1) Annual Travel Allowance.
- (2) Annual total benefit allowed for dependent health insurance coverage through county's approved health care provider at a rate of \$100 per month pending continuation of coverage.
- (3) Maximum amount of State Salary Supplement paid by the State of Texas through county's payroll (estimated).
- (4) Annual Cellular Phone Allowance. Maximum available.
- (5) In addition to other compensation/benefit specified, Constable specified earns from \$75 to \$100 per bailiff duty depending upon type of Court being served.
- (6) Constable Precinct 3 annual bailiff duties for District Court.
- (7) Officials noted eligible for up to an additional \$1,250 in FY2011 for annual deductible reimbursement benefit if qualified under county's health reimbursement program.
- (8) For ALL officials listed, additional compensation may be recorded for reimbursement of non-overnight business travel expenses pursuant to Internal Revenue Service regulations.
