FROM THE VETERAN SERVICE OFFICER

Happy New Year to all and I hope all have a blessed New Year.

In the first newsletters, I am asking all who receive this newsletter, to please pass on names and addresses of county veterans not receiving one and I will put them on the mailing list. My hope is to keep all our county veterans and families informed of their benefits after serving our county.

In the previous newsletter, I mentioned that the Texas Veterans Commission have some great persons working in the different areas of benefits, workforce and education. The Veterans of Foreign Wars, American Legion, Disabled American Veterans and other veteran organizations also have qualified representatives to help a veteran or a veteran's family file for benefits. A veteran can file a claim by himself if he has all his paperwork together, but I highly recommend that a service organization is involved with the claim. The form used to indicate that you want to use a specific organization to represent the veteran or family is VA Form 21-22. Once the organization has your Power of Attorney, VA Form 21-22, they can follow your claim through the VA process, hopefully with better results than going it alone. The VA Form 21-22 is filled out, then the form for compensation or pension is filled out, all supporting evidence and with a copy of discharge paper (DD-214), then mailed to the local Regional VA Office in Waco. I am here at the courthouse Suite 104 to help with process. Hope this gives you some indication of what is needed to file a claim and with whom.

I would also like to talk about the VA Healthcare. We are blessed to have some fine facilities in College Station and at the Temple VA Hospital. Temple VA has really expanded and very organized. If a veteran wants to get into the VA system, you will need to fill out VA Form 10-10EZ and with a copy of your discharge paper (DD-214). You will then mail to the College Station VA and they will respond with a yes and give you a phone number to call to make a doctor appointment, or if no they will give you a reason of the rejection. Again, I am here at the Burleson County Courthouse, Thursday and Friday mornings, 9am to noon, should a veteran need help with this.

If a veteran or a veteran's dependent is entering a college or school to further their education, please consult with the registrar of that school about the Hazelwood Act, to get help on tuition. Please have a copy of discharge paper (DD-214) with you.

Thank you to the Caldwell Elementary, Caldwell Intermediate, and Caldwell High School for hosting us on Veterans Day. All the veterans had a great time. Thank you to Comrade Rachael Medders for speaking, Caldwell High School Band, Caldwell Honeybees, and Caldwell Intermediate School Choir at the Civic Center program and Kovasovic Grocery for donating the hotdogs and buns for the lunch.

Thank you to County Judge Mike Sutherland and Mayor Norris McManus for your welcomes. Thank you to the City of Caldwell for donating the use of the Civic Center for this event. To the ladies of VFW Post 4458 Auxiliary, thank you for always being there to help.

Thank you to the nursing homes for inviting us to your facilities for the afternoon visits with the residents, St. Jo. Manor at 2pm and Copperas Hollow at 2:30pm. Veterans Day was well attended and we hope to see all at the Memorial Day Service at the end of May.

If you fly a United States Flag, please check it's condition and replace if worn or torn. Please keep all our veterans in your prayers, past, present, and especially those serving us today.

I am here at the Burleson County Courthouse, Thursday and Friday mornings, 9am to noon. If you would like to make an appointment, please call 979-567-6360 and leave me a message and I will return you call.

^{*}Because eligibility dates remain open, all members of the U.S. Armed Forces are eligible to join The American Legion at this time, until the date of the end of hostilities as determined by the government of the United States.

U.S. Merchant Marine eligible only from December 7, 1941 to December 31, 1946 (WWII).
