FROM THE VETERAN SERVICE OFFICER

Memorial Day is quickly approaching. American Legion Post 451 will host our local Memorial Services here at Burleson County Courthouse on May 28th at 11am. After the ceremony, American Legion Post 451 will host a light lunch at the VFW Post 4458. Should there be inclement weather the ceremony will be held at the VFW. Reverend Richard Brunk will be the guest speaker. The veterans will also visit Copperas Hollow Nursing Home at 9am, then travel to St. Jo Manor for a 9:30am short service. The nursing home veterans and residents enjoy the service and company of our local veterans. Please put in your schedule to attend.

More than seven decades have passed since World War 2, and the "Greatest Generation" is quickly disappearing. Of the 16 million Allied servicemen for the United States and 1.1 million from Canada, nearly 450,000 lost their lives during the war. Approximately the same number alive today, and they are dying at about the same rate as during WW2 – several hundred each day. Please let's remember them and all our veterans, living and deceased, this upcoming Memorial Day.

In the previous newsletter, I mentioned the service organizations that can help a veteran, their family, and survivors in matters pertaining to VA disability benefits and rights. These agencies represent veterans in VA disability claims and during the VA appeals process, and assist dependents with survivor benefits. The following comes from the 2018 State Veterans Benefits booklets from the Texas Veterans Commission.

Service-Connected Disability compensation is a tax-free benefit paid to a veteran for certain qualifying disabilities. Veterans may be eligible for disability compensation if they have a service-related disability and were not discharged under less than honorable conditions. Many veterans do not realize they may qualify for monthly payments due to health conditions that can be traced back to their military service.

Combat deployment is not required for a service-connected disability rating or compensation.

Service-connected disabilities are rated from 0% to 100%. Compensation amounts are based on rating and number of veteran's dependents.

VA compensation is not subject to Federal or State taxes.

VA will consider all disabilities when they are included within the claim. If service-connected disabilities rated at 60-90% cause unemployability, the veteran may be paid at the 100% rate by the VA.

Filing a claim and establishing service-connected disabilities provides certain priorities in obtaining medical care at VA expense.

Texas and many other states have special programs and benefits for veterans with service-connected disabilities.

Most claim payments start to accrue within a month from the day you file, no matter how long it takes to get the claim settled. Start the process today. I am here at the Burleson County Courthouse, Thursday and Friday mornings, 9am to noon.
