In the previous newsletter I wrote about Service-Connected Disability and what is needed to file a claim. In this issue I would like to pass on information about Non Service—Connected Pension and Death Pension. The following comes from the 2018 State Veterans Benefits booklet from the Texas Veterans Commission.

Non Service—Connected Pension is a monthly benefit paid to a wartime veteran who have limited or no income. Who qualifies? Veterans who: are 65 or older, or permanently and totally disabled; were not discharged from service under less than honorable conditions; meet active duty service requirements with at least 1 day during a period of war time (combat experience is not required); have a family income lower than the limit (depends on spouse/dependents). These requirements are general and there are additional factors that affect eligibility. Death Pension is, the VA provides pensions to low—income surviving spouses and unmarried children of deceased veterans with wartime service (combat experience is not required). The death pension provides a monthly payment to bring an eligible person's income level established by law. Who qualifies? To be eligible, spouses must not have remarried and children must be under age 18, or under age 23 if attending a VA—approved school, or have become permanently incapable of self—support because of disability before age 18. The veteran must have been discharged under conditions other that dishonorable and must have qualifying service. A surviving spouse may be entitled to a higher income limit if living in a nursing home, in need of the aid and attendance of another person, or permanently housebound. These eligibility requirements are general and there may be additional factors that affect eligibility.

Marion Mays Post 455 Somerville-

Veteran's Day this year will mark the 100th anniversary of the armistice that ended World War I. Post 455 in Somerville is named after Marion Mays, the first resident of Burleson County to be killed in action during World War I. He died on October 18, 1918 less than a month before the armistice was signed. One of our missions as legionnaires is to remember men like Marion Mays and all the veteran's who made the ultimate sacrifice in defense of our nation and way of life. World War I was supposed to be "the war that ended all wars", of course we now know that wasn't the case. Many conflicts and wars have been fought since and sadly many more will probably be fought in the future. "On May 1, 2018, Representative Tulsi Gabbard (HI) introduced H.R. 5671, the Burn Pits Accountability Act.

Since the Persian Gulf War, a common waste disposal practice at military sites outside the United States was the use of burn pits. Smoke from these pits contained toxic substances that may have short- and long-term health effects, especially for those who were exposed for longer periods. Many service members reported acute symptoms of respiratory or eye irritation, gastrointestinal distress, or rashes during or shortly after exposure, but the research thus far has been inconclusive about whether there are longer lasting consequences to these exposures, as many veterans still struggling with conditions that arose during or after military service believe.

H.R. 5671 will require the Secretary of Defense to ensure that periodic health assessments ascertain whether a service member has been at a location when an open burn pit was used or exposed to toxic airborne chemicals. It will further require the Secretary of Defense to enter into an information sharing agreement with the Secretary of Veterans Affairs. If a service member was exposed, the VA Secretary will enroll the member into the VA Airborne Hazards and Open Burn Pit Registry, unless the member elects not to enroll.

In agreement with DAV Resolution No. 120, DAV supports H.R. 5671-legislation that would ensure that exposure to burn pits and airborne chemicals are recognized by both the Departments of Defense and Veterans Affairs.
