

FROM THE VETERAN SERVICE OFFICER

I would like to thank Burleson County Judge Mike Sutherland and the County Commissioners for promoting this newsletter to communicate veteran's issues to our county veterans. Burleson County has approximately 1300 veterans in the county, with about 300 who are members of our local organizations. As the Service Officer of the county, Veterans of Foreign Wars Post 4458, American Legion Post 451, and Disabled Veterans Chapter 86, I get to visit with a portion of our local veterans at the meetings, to inform them of their benefits earned as being members of the armed forces. Due to the Privacy Act, I cannot use an organization membership list for this mailing With this newsletter, hopefully I can pass on some information to all our veterans and with your help, please inform family, friends, and neighbors who are veterans of this communication. I can add them to our list. My office phone number is (979)567-6360, if I do not answer, please leave a message

and I will return your call.

After being in this position for almost six years, I see approximately 50 vets and families a year. The biggest request is for "finding a copy of the veterans discharge papers". Once a veteran leaves the service he or she is informed to have their discharge papers recorded at their local county clerk's office, this is done for free for veterans. Some veterans discharge papers have been lost in fires, stolen, misplaced, etc. All veteran's benefits revolve around this form, such as health, school, applications, etc. Your spouse or family will need this form when doing military funeral services or applying for benefits. Be sure to keep them in a safe place. If you need assistance with getting yours, or need more information on benefits please give me a call or stop by my office at the Burleson County Courthouse, Thursday or Friday mornings, 9am to noon.

We have a highly qualified Chapter Service Office who can assist disabled veterans in filing forms with the Veterans Administration for benefits. State of Texas Benefits- Benefits & Services for Veterans, Dependents & Survivors

Property Tax Exemption- Disabled Veterans, their surviving spouses and the spouses and minor children of a person who dies on active duty in the U.S. Armed Forces are eligible for property tax exemptions on the appraised value of their property. The VA rating in effect on January 1 of each year determines the exemption for that entire year. Veterans who are rated 100% due to service connected disability or in receipt of 100% compensation due to a grant of individual unemployability are entitled to an exemption from taxation of the total appraised value of the Veteran's residence homestead. Adjustments to an exemption for ad valorem taxation of the residence homesteads of certain tottally disabled Veterans and to the amount from ad valorem taxation to which a disabled veteran is entitled are based on the disability rating by the U.S. Department of Veterans Affair (VA) or a branch of the Armed Forces. Eligible Veterans must hace a minimum 10% serviceconnected disability rating. Veterans with a rating of 0% are not entitled to a property tax exemption.

Disability Rating		Tax Exemtion
At least	but less than	
10%	30%	First \$5,000 of appraised value
30%	50%	First \$7,500 of appraised value
50%	70%	First \$10,000 of appraised value
70%	100%	First \$12,000 of appraised value

A Veteran who has a disability rating between 10% and 90% and who is 65 years or older is entilited to a tax exemption for the first \$12,000 of the property's appraised value. The surviving spouse of a person who dies on active duty is entitled to exemption of the first \$5,000 of the appraised value of the spouse's property. A surviving child of a person who dies on active duty is exempt on the first \$5,000 of appraised value of the property, as long as the child is unmarried and under 21 years of age. The surviving spouse of a deceased veteran, who at the time of death had a compensable disability and was entitled to an exemption, is also entitled to that exemption if the surviving spouse is unmarried but currently NOT at 100% of the appraised value.

In May 2011, the Legislature unanimously passed measures that, if approved by Texas voters on November 8, 2011, will extend the 100% property tax exemption to totally disabled or unemployable Veterans to their surviving spouses. If approved by voters, the legislation would entitle the surviving spouse to the 100% property tax exemption if:

- The property was the surviving spouse's homestead when the Veteran died;
- The property reamins the surviving spouse's homestead, and
- The surviving spouse has not remarried since the death of the disabled Veteran.

The spouse is not obligated to remain in the original home so long as the new home is designated a homestead and the spouse does not remarry. If passed by the Texas voters, the new exemption would take effect on January 1, 2012. In these cases the Tax Exemption caps at the 70% to 100% of the first \$12,000 of appraised value. Applications for the exemption must be completed between January 1 and April 30. To apply, obtain an application from the local appraisal district office for your county.
