4) Department Reports: On Sheriff's Report –Sheriff Gene Hermes reported they have hired 2 new deputies and one position short in the Jail. Chief John Pollack gave report on the Winter Storm Report on the following Calls: Deputies Responded to or handled 230 calls and 911 Dispatch Calls were 424. (See attachments) Captain Smith reported they have 52 in Jail, with us holding 6 males for Milam County. Captain also reported they have two new hires in the Jail and that the Jail has several water leaks every time it rains or snows a lot. County Attorney-Susan Deski reported that we may be able to set Jury Trials for April and she thanked the Law Enforcements efforts and coordination through the week long winter weather storm. County Treasurer-Stephanie Smith spoke about the administration leave and how to fill out their timesheets.
