




The members of Commissioners Court of Burleson County state as follows:



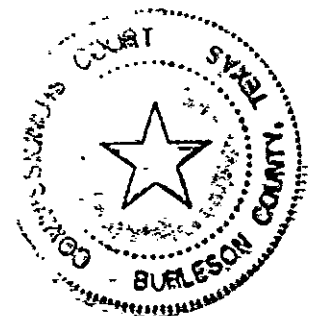

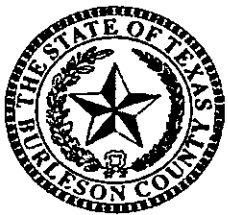

ORDER APPROVING TREASURER'S QUARTERLY REPORT


