BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 28th day of January, 2022 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Carol Hill present and Deputy County Clerk-Sharon R. Burgess were in attendance when the following business came before Court:

- 1) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.
- 2) Prayer was given by Reverend Steve Johnson.
- 3) No Public Forum.
- Department Report: On Sheriff's Report Sheriff Gene Hermes reported that coming up is the building inspection for the Jail and fire inspection on March 6. There are holes in the ceiling, but they have to get roof fixed first and material could take 6 weeks to six months to get. Due to all of this needing to get fixed the fire inspection will be incomplete and the Jail inspection will not pass because they have not been in compliance for 1 year. Sheriff also reported patrol is fully staffed and dispatch is going good. They have 57 in Jail and 2 from Milam County. Sheriff also reported that Marshall Bengs is the new K9 Officer. County Attorney reported that felony trials are up and running and that OCA came for a walk through of Courthouse Security and will generate a report. Environmental Officer talked about TCEO.
