BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 11th day of July, 2022 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Carol Hill present and Deputy County Clerk-Sharon R. Burgess were in attendance when the following business came before Court:

- 1) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.

- Department Report: On Sheriff's Report Sheriff Hermes talked about K9, and he thanked Commissioners Court for supporting the K9 and their ceremony at the Civic Center. Chief Pollack reported they are fully staffed in Patrol, K9 program is up and running and 2 vacancies in Dispatch. Captain Smith reported they have 45 in Jail and 4 males from Milam County, and the Jail staff is full. Robbie Myers with Environmental Office reported last year in July there were 97 new septic permits and to this date this year, there are 156 new septic permits. Out of the Auditors Office-Raileen Murray our grant coordinator reported doing grant actions today and she wants to set up meetings for the different grants in the near future or even this week, and to organize the new grants out there. With inflation it was decided by the Court there will be a 50% increase to \$12,000.00 per well. The Court is oaky with negotiating this increase.
