BE IT REMEMBERED, That a Special Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 8th day of September, 2022 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Carol Hill present and County Clerk-Anna L. Schielack were in attendance when the following business came before Court:

Judge Schroeder called the meeting to Order.

1) Motion made by Commissioner Hildebrand and seconded by Commissioner Svec to Approve and Act upon 2023 Contribution rates for Texas County and District Retirement System and/or Cost of Living Adjustment (COLA) for retirees being 10.56% County Portion going up 200 Forward + 5 (COLA).

7) Motion made by Commissioner Hill and seconded by Commissioner Svec to Approve and Act upon Ratifying Property Tax Increase in the FY2023 Budget.

8) Motion made by Commissioner Hildebrand and seconded by Commissioner Svec to Approve and Act upon Setting 2022 County Property Tax Rates that exceeds NNR or VAR: “ I move that the property tax rate be increased by the adoption of a tax rate of 0.5000, which is effectively a 18.25 percent increase in the tax rate.”. “The rate consists of the following components M&O \$0.41297, I&S \$0.01203, FM Road \$0.07500.”
