BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 10th day of October, 2023 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Robert (Bobby) Urbanosky present and County Clerk-Anna L. Schielack were in attendance when the following business came before Court:

- 1) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.
- 2) Prayer was given by Judge Keith Schroeder.
- 3) On Public Forum- Bruce Alford reported from 9:04-9:06 a.m. that he didn't have the Hotel/Motel Application submitted or put on the agenda for his Mass Gathering Permit Application under Bluebonnet Overlanding, LLC.
- Department Report: Chief Rios reported they have 46 in Jail with 39 males and 7 females, with 3 patrol, 5 jailers, 2 dispatch positions and 2 SRO's positions opened within the Sheriff's Department. Shawn Edwards reported we had 52 Jail diversions in working with the County Attorney's office and the County Judge and the District Judges in the amount of \$390,074.
