

OSSF for RVs and/or mobile homes on a single tract of land

Use the questions below to determine if you will need to complete the Affidavit of Non-Rental

1. How many RV's and /or mobile homes will be on the property? _____ (2 or more, see question #2)
If there will only be a single RV and/or mobile home on a single tract of land you do not need to complete the Affidavit of Non-Rental.

2. Will you rent the spaces/dwellings located on this property at any time?

YES. If you plan to have two or more rental spaces/dwellings such as RV's/mobile homes on a single tract of land you must go through Burleson County subdivision regulations prior to submitting an OSSF application.

NO. You must complete the Affidavit of Non-Rental. The affidavit must be submitted to the Burleson County Clerk's office and a copy must be submitted with your OSSF application.
