BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 8th day of January, 2024 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Robert (Bobby) Urbanosky present and County Clerk-Anna L. Schielack were in attendance when the following business came before Court:

- 1) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.
- 2) Prayer was given by Pastor DeWet Steyn.
- 3) On Public Forum- Janet Hightower Schafer spoke from 9:04 a.m.-9:10 a.m. with concerns of lack of cooperation with the Sheriff Department. (See attachments)

Sheriff Gene Hermes reported they have 49 in Jail with 45 males and 4 females, with 2 patrol ,2 jailers, 2 dispatch, 2 SRO's and 2 CID positions opened within the Sheriff's Department and the Jail. Angie Jones with 911 addressing reported they had 566 for the year of 2023 with 545 being residential and 21 commercial or oil and gas addresses. Jessica Lucero, Tax Collector reported that on November 30, 2023 tax statements were mailed out with a problem on minerals, and due to the rain the motor vehicle registration with the State goes down, but they have a work order in place. Also the Tax Office discovered during registration of a stolen vehicle, in which they reported to the Sheriff Department and the City Police with total cooperation. D. J.
