BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 24th day of February, 2025 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Bobby Urbanosky present and Deputy County Clerk-Sharon R. Burgess were in attendance when the following business came before Court:

1) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.

2) Prayer was given by Pastor Basel Lister from Lyons, TX.

3) On Public Forum-Melynda Giesenschlag spoke to the Court from 9:04 a.m.-9:07 a.m. that the Burleson County Historical Commission will be presenting 2 Historical Markers, one being March 8 at Shiloh Baptist Church and the other one will be on April 5 at St. Matthew's Baptist Missionary Church.

4) Department Report: On Sheriff's Report – Chief William "Bill" Rios reported they have 59 in Jail with 50 male and 9 female. The positions opened in the Sheriff's Department are 4 in dispatch, 3 in patrol, 2 jailers, 1 full time nurse for the Jail and 1 SRO in Somerville. Chief Rios also reported that as he spoke, a jail inspection was being done by Jail Commission. Amy Jurica with the Burleson County Historical gave a report for the 2024 Year End Summary Report with their volunteer hours and the monetary value and the month per month report. (See attachments). Jessica Lucero our Burleson County Tax Assessor Collector thanked everyone for their support during their remodel. Our Environmental Officer-Jody Tillery reported many things: In Precinct 1-there was many individuals without tags for the collection station amounting to \$1,500.00. They have a trailer set up for tire clean-up. There has been issues with Animal Cruelty and he has been helping the Sheriff Department with this issue. He has been having problems with Cade Lake Estates and illegal septic systems. Also so far this year compared to last year the septic system permit and inspections have been slow. Jody also informed the Court that he shut down 7 trucks for Sand Plant due to the unsecured loads and illegal dumping of sand everywhere in the county.
