BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 24th day of March, 2025 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Bobby Urbanosky present and County Clerk- Anna L. Schielack were in attendance when the following business came before Court:

- 1) Judge Keith Schroeder informed the Court that it was Burleson County's 179th Birthday and that after the meeting was adjourned, the Court would attend the Celebration with the Burleson County Historical Commission on the 1st Floor.
- 2) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.

Sheriff's Report –

Chief Deputy Rios reported that the Sheriff's Department has the following openings: two jailers, three dispatchers, one full-time nurse, three patrol officers, school officer in Somerville and possibly one investigator. Chief Rios also reported that there are 56 inmates (45 males and 11 females)

CIT Deputy Shawn Edwards reported that there was a Juvenile SIM Mapping training led by Pam Kothman. He also reported that there was a 40,000.00 donation from State to help juveniles in the Judicial System with the school.

Emergency Management Report:

Duane Strange had no report but just reminded everyone about the upcoming events (Chili Fest which will bring in about 20,000 people each day, Crater Rally at Welch Park bringing in about 850 people and the 2025 Bike MS: Texas MS 150 bringing in about 6000 riders).

Goal is to not have the landfill in this county,

22) Auditor's Report:

Auditor Jimmy Mynar reported Sales Texas received \$106,157. Sales Tax is down 0.164% compared to March 2024. He also reported that the remodel in the Tax Office is still progressing good.
