A RESOLUTION OF SOMERVILLE ISD, SOMERVILLE TEXAS APPOINTING THE EARLY VOTING BALLOT BOARD AND CENTRAL COUNTING STATION BOARD FOR THE MAY 3, 2025, ELECTION.

WHEREAS, the Texas Election Code requires that an authority conducting an election appoint the Early Voting Ballot Board for each election; and


WHEREAS, Somerville ISD Board of Trustees, as the authority conducting an election for the School Building Bond on May 3, 2025, desires to appoint the Early Voting Ballot Board and Election Judge/Alternate Judge in accordance with the Texas Election Code provisions.

NOW, THEREFORE, BE IT RESOLVED BY THE SOMERVILLE ISD BOARD OF TRUSTEES, SOMERVILLE TEXAS THAT:

1. The following persons are hereby appointed to the position(s) indicated:
2. The Early Voting Clerks appointed by Somerville ISD shall be Ninfa Stevens, Cecily Young, Amber Wilson, and Christy Webb.
3. The Early Voting Ballot Board Judge appointed by Somerville ISD shall be Donald Rosser and shall serve as the Central Counting Station Judge.
4. The Alternate Early Voting Ballot Board Judge appointed by Somerville ISD shall be Thomas Hill and shall serve as the Alternate Central Counting Station Judge.
5. The following persons are hereby appointed to the position indicated:  
ELECTION JUDGE: Karen Law  
ALTERNATE ELECTION JUDGE: Erlinda Espinosa  
The Election Judge is authorized to appoint three (3) clerks with the Alternate Election Judge serving as an authorized clerk.
6. The rate of pay for the Early Voting Ballot Board Judge and the Central Counting Station Judge and any clerks is hereby set at \$15.00 per hour. The Election Judge is authorized to be paid an additional flat fee of \$25.00 as compensation for time and travel involved in securing election supplies, setting up the polling place, delivering the records and supplies after the election, and similar additional duties involved with that position.
7. All appointments herein made or authorized are for a period of one year from the date of this resolution.
