Footnotes: Other Compensation/Benefits in addition to Base Annual Compensation

- (1) Annual Travel Allowance.
- (2) County Attorney salary paid by the State of Texas pursuant to SB891 – 86(R).
- (3) Maximum amount of State Salary Supplement paid by the State of Texas through county's payroll (estimated).
- (4) Annual Cellular Phone Allowance. Maximum available \$360.
- (5) In addition to other compensation/benefit specified, Constable specified may earn from \$100 to \$200 per bailiff duty depending upon type of Court being served.
- (6) For ALL officials listed, annual total benefit allowed for dependent health insurance coverage through county's health care provider at a rate of \$200 per month pending continuation of coverage. Maximum available \$2,400.
- (7) For ALL officials listed, additional compensation may be recorded for reimbursement of non-overnight business travel expenses pursuant to Internal Revenue Service regulations.
- (8) For ALL officials listed, beginning with Fiscal Year 2024, additional compensation may be paid annually for longevity in the amount of \$10 per month of service as approved by commissioners court.
- (9) Constable extra duty pay as related to qualifications of activities under SB 22 (88R).
